EXELIA E.E., with its registered offices in 5 Sokrati Tsakona, Penteli, Attica, 152 36, Tel: +30 210 6420440, e-mail: <a href="mailto:info@exelia.gr">info@exelia.gr</a>, web: <a href="mailto:www.exelia.gr">www.exelia.gr</a> and VAT ID: EL800474176, submitted its offer on 28<sup>th</sup> of April 2017, according to the terms of the invitation for tenders PRI.052.2.41.2017.AJ, via the respective online form.

According to this decision/ information on the results published on 4<sup>th</sup> of May 2017 by Lodzkie Region, our company, ranked second with 91pkt., and as a result cannot be the concessionaire of the contract. The result is calculated based to a wrong price, different than the one mentioned in our submitted offer. The price offered by our company is 29.250 PLN (gross price) and not the 35.997,50 PLN mentioned in the decision file.

As already mentioned in the offer uploaded to the system (on 28<sup>th</sup> of April 2017), EXELIA E.E. is registered in the VIES and thus does not charge VAT for intra-community provision of services to entities also registered in the VIES (EU law 2008/8/CE and Council Directive 2006/112/EC Article 196).

According to the official TAX database of European Commission, Lodzkie Region is VIES registered and thus there is no charge of VAT on top due to the reverse charge mechanism on cross border provision of service.

The net and gross price offered by EXELIA E.E. are the same and equal to 29.250 PLN.

With this letter, we officially request, our offer to be re-evaluated on the basis of the correct, offered, price. In addition, we ask to be informed on the minutes of the assessment procedure and the technical offers of the other two companies, according to procurement transparency rules.
